Water Repellent Preservative Non-Pressure Treatment for Millwork Licensees

The Window & Door Manufacturers Association has received requests from Licensees under its Water-Repellent Preservative Treating Certification Program for approval of various water-repellent preservative formulations. Accordingly, for the benefit of these licensees, WDMA has reviewed tests of these formulations. These tests revealed that the following formulations meet the requirements of WDMA I.S.4, Industry Standard for Water-Repellent Preservative Treatment of Millwork, and are acceptable for use under the WDMA Water-Repellent Preservative Treatment Certification Program.
